

COUNCIL MINUTES

May 6, 2019

The City Council of the City of Knoxville, Iowa convened in regular session Monday, May 6, 2019 at 6:15p.m. in the City Hall Council Chambers. Mayor Brian Hatch presided and the following Council Members were present: Megan Suhr, Rick Kingery, Dylan Morse and James Lane via phone. Discussion Regarding Property at 314 S Fremont Street. The property owner had offered the home to the Fire Department to use as a training burn.
